**TERMS & CONDITIONS**  
**Deposits and fees.**

The Hirer is required to pay non-refundable deposit of £400.00 minimum to confirm a booking the ("DEPOSIT"), payment to be made within seven days of the verbal confirmation of the booking.

. If the deposit is not paid to king cruises within 7 days of the verbal confirmation king cruises may cancel the booking in question.

. Balance including costs of catering, music and any other requirements is to be paid no later than 21 days prior to the date of function.

**Cancellations.**

. If the hirer cancels within 6 weeks of the date booked he or she will remain liable for the full costs of the charter as it is highly unlikely king cruises will be able to re-let this date.

. If possible king cruises will try to transfer functions to another date agreeable to both parties.

. Company cancellations Due to unforeseen circumstances functions will be transferred to another vessel of similar size and style.

**Hire Terms**

. Boat Hire is based on a minimum of 4 hours Hire. any hours over and above have additional costs.

. Vessels are allowed on the pier from 15 minutes before your embarkation time and will return to the pier 15 minutes before the disembarkation to allow time for passengers to disembark

. Embarkation and disembarkation or any additional pier stops will be charged at £50.00 per stop subject to availability. Higher fees apply to privately owned piers.

. For your own safety and the safety of others you must follow instructions given by king cruises crew when on board our vessels.

. For safety reasons smoking is permitted on designated outside decks only.

**. The crew may refuse to carry any passenger, or direct any passengers to disembark, were the behaviour of that passenger is liable to cause nuisance or offence to the other passengers or put at risk the safety of the passenger or other passengers, crew or vessel.**

**. Any passenger who wilfully damages the vessel, the interior parts or equipment will be liable for the cost of the repair or replacement.**

### **Catering Terms**

**. No less than 21 days prior to the function should the hirer notify king cruises of the minimum number of guests expected, menu choices and wine selection?**

**. If the number of guests was to decrease within the 21 day period the hirer is still liable.**

**. All prices are quoted exclusive of VAT.**

**. Changes to specification should the event change from the original quoted specification then your costing will be revised accordingly.**

**. Cancellations the minimum cancellation charge is 50% if the hirer cancels up to 8 weeks before the event this will increase to 100% if you reach the 21 day period.**

**. Own catering is not permitted on any of king cruises vessels.**

### **Bar terms.**

**. Fully licensed bars operate on all of king cruises vessels and operate over 21 policy**

**. No person under the age of 21 is permitted to consume alcohol on board king cruises vessels.**

**. If anybody is seen to be buying alcoholic drinks for anybody underage the function will be terminated.**

**. Own alcohol is not permitted on any of king cruises vessels if any passengers bring a bottle on board it will result in being charged for the bottle per shot or termination of the function.**

**. ID is required to purchase alcohol on board king cruises vessels.**

. King cruises will not be liable for any persons who cause harm to themselves or other passengers due to being intoxicated.

. As soon as king cruises vessels touch the pier we are to stop serving alcohol due to licenses.

#### **Entertainment terms.**

. Clients are permitted to supply entertainment with a negotiated surcharge all electrical equipment supplied by any act must carry P A T certifications.

. All equipment must be supplied by the client for own entertainment as king cruises does not have any spare equipment on board.

. The hirer pays all deposits for outside entertainment I.E Bands casinos ETC.

. As soon as king cruises vessels touch the pier all loud music or bands are to stop playing due to licences.

#### **Loss / Damage terms.**

. King cruises will not be liable for any loss or damage of personal possessions whilst embarking or disembarking from the vessel or during the cruise.

. King cruises will not be liable for any accident, injury, loss, damage or delays to persons embarked or their possessions.

. King cruises Cleans all vessels immediately after events so if any lost property is found king cruises will notify the organiser of that evening.
